About making your will

- 1. Pennsylvania taxes bequests to religious and charitable organizations 10%. What is your state law? From what part of your estate shall the inheritance tax be paid?
- 2. Life insurance is not usually taxable unless left to the estate rather than to a person.
- 3. One may reduce the cost of inheritance tax by creating a trust which transfers the estate through two generations instead of by bequest of outright ownership.
- 4. Have you considered possible shrinkage in your estate and provided first for most important matters? It is safer to leave a percentage than a lump sum to special objects. Show due care for your family.
- Have you fulfilled legal requirements of proper witnesses, naming all possible heirs, considering problems of children under age, keeping your will up-to-date? See Covenanter Witness, December 4, 1935, page 358.
- 6. Have you secured the advice of a competent and trustworthy lawyer? It should not cost much.
- 7. Have you considered the needs of the Covenanter cause when you are gone?
